Inclusion of Mundra as a Town of Export Excellence (ToEE) under Foreign Trade Policy (FTP) for Chemicals, Electronics, Engineering and Textile Sectors.

Ref:

Your letter No.01/94/180/05/AM-21/PC-1/TEE/7 dated 3/12/2020.

We refer to your above letter requesting us to certify the exports done by DTA units present in the town of Mundra, and outside the SEZ for the sectors like Chemicals, Electronics, Engineering and Textile sectors, individually for the past three years.

The town of Mundra has several small and medium industries in the DTA. However, GCCI does not have a compilation of the production turnover of these small and medium scale industries. In this connection, we would like to state as under:

- a) FTP focus is to identify export potential production hubs. ToEE criterion does not prescribe that the export from DTA alone shall be taken into account. In fact, the only threshold requirement of notifying a ToEE is that the value of goods produced should be Rs 750 Cr (Para 1.35 of FTP). The FTP aim is to maximize the potential for these export production centers, and enable them to move up the value chain and also to tap new markets.
- b) Even towns in which SEZ is operational are export production centers. In the current list of notified ToEEs, several operational SEZs are functioning. Surat has an SEZ for G&J Sector, Ahmedabad has an SEZ for Textiles Sector (GIDC), Jaipur has SEZs for Handicraft (Mahindra World City), to name a few. Hence, excluding SEZ production hubs would be contrary to objective of ToEE policy.

c) At this juncture, we would like to point out to your good self that the benefits under MEIS and SEIS Schemes of FTP are entitled on exports from SEZ also.

d) The details of economic activities of companies provided vide our letter dated 11.08.2020 are operational in the Mundra SEZ. Since, there is no specific requirement/criteria laid down in the FTP that the industries need to be located in DTA only, we plead that Mundra, having as Chemicals (Turnover FY2019-20 - Rs 873 Cr), Electronics (Turnover FY2019-20 - Rs 2481 Cr), Engineering (Turnover FY2019-20 - Rs 1199 Cr) Sectors, each of which are individually producing goods of value more than the required criterion, may kindly be considered for declaring Mundra as a ToEE for these Sectors.

e) Only the Textiles sector in Mundra, the threshold is below 750Cr since the sector Turnover in FY2019-20 is Rs 539 Cr. However Textile Sector production is likely to cross 750 Cr in coming few years.

Once Mundra is recognized as a Town of Export Excellence, it is expected to receive more focus and would, consequently be able to attract large scale investment at a faster pace, which will lead to higher employment generation and higher export potential from Mundra, meeting the twin objectives of the FTP. In view of above, it is requested that your good offices may consider the request favourably and notify Mundra as a ToEE for Chemicals, Electronics, and Engineering Sectors having achieved the required criterion.
